Supervisor Report...

The seasons are changing and so are things on your board. After 17 years of service, we bid farewell to Supervisor Allan Berg. Trustee Toby Kuznicki was appointed Supervisor, and Building and Grounds person Rich Kamyszek was appointed Trustee. The Township has contracted with Burg Assessing and Consulting for tax assessment.

I am pleased to introduce myself as Supervisor. My name is Toby Kuznicki and have served the township since 2018 as Trustee. With over 15 years of experience in local government, I am the City Planner for the City of Rogers City and a member of the Presque Isle County Planning Commission. My connection to Belknap is deep, my children and I live on our family farm in the same house where I grew up. Feel free to contact me if you would like to discuss Township matters.

As to Township business, we are working to move past the uncertainties of a COVID world and finally get back a new normal. Some of the current topics we are discussing include: strategic planning for roads and the Township Hall & grounds. The Township has applied for Federal monies from the Coronavirus Local Fiscal Recovery Fund (CLFRF) which have limitations on how they can be spent. We are working to come up with a plan for use of these funds.

The Township Road millage expires in 2021. It generates about \$23,000/year and helps pay for special road projects. The average reconstruction cost is over \$250,000 per mile, and the average chip and fog seal treatment costs about \$30,000 per mile. Without the voter's continued support of the Township Road Millage, these projects would not be possible. The road millage will be on this year's ballot.

Assessing Update - 20% Property Inspections

Please check your tax bill to ensure your PRE exemption is correct. If not, please contact us at 989-734-3555 before December 9, 2021. Appointments for the December Board of Review must be received before December 9, 2021.

As you may be aware, Belknap Township has completed inspections on all parcels in the Township throughout a 5-year period (20% per year). As recommended by the Michigan Dept. of Treasury, we are scheduled to continue 20% each year and start back through the Township. Therefore, you will notice staff inspecting your property again even though it was done approx. 5 years ago. All notices go out in the spring for those parcels to be inspected for that year. Thank you for everyone's cooperation with this process.

Without this information, we are not able to send you your tax bill, assessment notices, and any correspondence that may be needed on a timely basis.
